## WAIVER, RELEASE, AND COVENANT NOT TO SUE

In consideration of the Music City Tactical Shooters permitting me to engage in firearms shooting activities of the Music City Tactical Shooters wherever the same are held, I, on my own behalf and on behalf of my heirs, representatives, administrators, and assigns, hereby wave and release any and all claims, demands, causes of action, suits, and rights I, or anyone on my behalf, might have against the Music City Tactical Shooters, its officers and/or directors, its members, and range owner, Tim and Vickie Wheeler, for personal injury (including death), loss or damage to my property which I (or anyone claiming by or through me) may have against the Music City Tactical Shooters, its officers and/or directors, range owner, and members, as a result of my taking part in the firearms shooting activities sponsored by, sanctioned by, or approved by the Music City Tactical Shooters, its officers, and/or directors, its members and the range owner.

Further, I agree that I will not, nor will anyone acting on my behalf claiming by or through me, bring or maintain any suit in Court to assert any claim against the Music City Tactical Shooters, its officers and/or directors, its members, and the range owner, for any claim against that I might have arising out of my participation in any activities sponsored by, sanctioned by, or approved by the Music City Tactical Shooters, its officers and/or directors, its members, and the range owner.

I UNDERSTAND THAT ENGAGING IN FIREARMS SHOOTING ACTIVITIES CONSTITUTES MY INVOLVEMENT IN A VERY HAZARDOUS AND DANGEROUS ACTIVITY WITH ACCOMPANYING RISKS OF PERSONAL INJURY OR DEATH AND LOSS OR DAMAGE TO PERSONAL PROPERTY, AND I HERBY VOLUNTARILY ASSUME THOSE RISKS.

MY SIGNATURE ON THIS DOCUMENT CERTIFIES THAT I AM AT LEAST 21 YEARS OF AGE AND THAT I MAY LEGALLY POSSESS FIREARMS AND THAT I WILL NOT USE ANY SKILL I LEARN WHILE PARTICIPATING IN THE AFOREMENTIONED EVENTS FOR ANY ILLEGAL ACTIVITY.

I have read and understand the foregoing provisions of this Waiver, Release, and Covenant Not To Sue and I have executed this instrument voluntarily on this date.

I recognize that the Music City Tactical Shooters, its officers, and/or directors, its members, and the range owner are not obligated to permit me to participate in any of the Music City Tactical Shooters activities and may terminate my participation in such activities at any time and for any reason.

The effect of this instrument shall not preclude the prosecution on any claim that I might have against persons or corporations other than the Music City Tactical Shooters, its officers and/or directors, its members, and the range owner. In other words, I am releasing waiving my rights and agreeing not to sue the Music City Tactical Shooters, its officers and/or directors, its members, and the range owner.

I understand that Tim and Vickie Wheeler, Owners, gives permission to use range for recreational shooting only.

This instrument shall remain in full force and effect indefinitely.
